THE CREATION OF MANKIND

Why was mankind created? This is a simple question that many Christians struggle to answer. I was born again at a young age and walked away from the Lord. When I came back to Christ as a young adult, I asked older Christians this question and most of them told me that they did not know. Others guessed it was because God was lonely and created Adam in order to have someone to talk to. It would be years before I finally found the answer. This is what the Bible says about this subject:

In the beginning, God created all the angels. (Job 38:1-7)

God told the prophets Isaiah and Jeremiah that a high ranking angel, a cherub named Lucifer, was given the planet earth to govern and rule. (Isaiah 14:12-21; Ezekiel 28:1-9; 11-19)

After having ruled the earth for an unknown period of time before the creation of Adam and Eve, Lucifer revolted against God and traveled throughout the universe in order to recruit other angels and join his rebellion. One third of the angels decided to join Lucifer. (Revelation 12:3-4)

Lucifer and the fallen angels tried to unseat God and started a war in the heavens. The Bible does say how long this war lasted, but it raged throughout the entire universe. Michael and the holy angels eventually drove Lucifer and his armed forces from the entire universe and the last battle took place in our solar system. The battle scars from this last assault can be seen in the ravaged surfaces on the moon and the planet Mars. The surface of the earth was totally destroyed. (Revelation 12:7-10; Genesis 1:2)

Jesus stated that Satan and his fallen angels were sentenced to the Lake of Fire. This indicates that there must have been a trial for Lucifer and his angels. (Matthew 25:41)

At this trial, Lucifer accused God of being unrighteous. Why would a loving God sentence His creatures to everlasting punishment in the Lake of Fire? God restored the earth from the destruction of the space war in order for God to prove His righteousness to all angels. (Genesis 1:2)

Mankind was created in the image of God to prove His righteousness. (Genesis 1:26-27; Romans 3:21-26)

Just like in a trial in the United States, there is a judge, jury, prosecutor and a defender. Jesus is our defender and Satan is the prosecutor. The jury consists of all angels, the saved people in heaven and all the unsaved people in hell. Those of us living on earth are the witnesses. Every time a person is born again, it testifies to the righteousness of God. In order to discredit every witness for God, Satan has the legal right to challenge every believer in Christ. (Luke 22:31-32; Revelation 12:10)

HEAVEN'S TELEVISION NETWORK

There are angel civilizations encompassing our entire universe. They exist in the spirit dimension, but they are also connected to the physical world in which they operate. A reference to how angels live can be found in the Book of Revelation where we are told of the new Jerusalem coming down from heaven. This city is prefabricated outside the universe and then relocated to the new earth in the second universe. This huge cubic city contains thousands of levels with a volume of 1,377 miles wide, deep and tall.

It is likely that the angel civilizations have built similar cities, floating over the different places where they exist throughout the universe.

According to the Bible, there is some kind of live broadcast from earth that is viewed in heaven. (Luke 15:7; Hebrews 12:1)

We are also told there are certain angels with the title "Watchers," who are in charge of events on earth and the control of human behavior. They are in control of political leaders and monitoring the human race. They have been provided with written laws, and when humans violate these laws, the Watchers have the authority to mete out punishment. (Daniel 4:13-17)

This is corroborated in a revelation given to the prophet Zechariah. (Zechariah 1:8-11)

This information also validates the account provided by Job. (Job 1:6-12; 2:1-7)

This leads me to believe that angels have a television network just like mankind. This heavenly network follows events on earth as humanity is confronted with the Gospel and how we live our lives. Thus, the fall of humanity in the Garden of Eden was seen by the angels on live television in heaven.

Jesus referred to global human television when He foretold of the last of God's prophets during the reign of the Antichrist. (Revelation 11:1-13)

A SUPERNATURAL EVENT

Jesus wanted to let the people of Israel know that He was real. What words would you use to describe a spacecraft that appeared in front of you? Could a primitive man without the knowledge of electricity fare any better? Moses said there was thunder and lightning's upon the mountain, a thick smoke came upon the whole mountain as it was shaking and there was a loud sound like a trumpet. Whatever Moses and the people saw, it made a deep and lasting impression upon them. (Exodus 19:16-20)

A LASER

Gideon had a supernatural experience with an angel of the Lord. After Gideon had been informed that God was going to use him to set the people of Israel free, he voiced his doubt and asked for a sign. Gideon said the angel of the Lord carried a staff, and when he pointed it at the offering Gideon had prepared, a fire consumed the meat and the unleavened cakes. What Gideon described sounds like a powerful laser that evaporated the meat and the cakes. (Judges 6:11-22)

A PORTABLE THRONE

The prophet Ezekiel was active from 593-571 B.C. and the Lord visited him in some kind of a flying object. Ezekiel did not know about helicopters or airplanes, and like Moses, he certainly did not know that electricity existed. This primitive man tried to best describe what he saw. What can we learn from his words? God and the angels have some kind of craft in the spirit world that they are able to bring into the physical realm. (Ezekiel 1:1-28)

A CHARIOT OF FIRE

Elisha knew that God was going to take home the prophet Elijah and he saw something so technically advanced that he had difficulty describing it. The best he could do was liken it to horses of fire pulling a chariot that seemed to be on fire as well as Elijah was lifted by a whirlwind. (2 Kings 2:10-13)

WHAT DID ADAM AND EVE KNOW?

Looking back from our perspective of having a Bible that has told us about the past, Adam and Eve were vulnerable and more or less "sitting ducks." They had no knowledge of what had taken place in the heavens before they were created. They did not know what good and evil were. They were created sinless with a body, soul and a spirit, and as far as they knew, they only existed to take care of the Garden of Eden. They had been strongly warned they would die if they ate from the Tree of Knowledge of Good and Evil. (Genesis 2:15-17)

ENCOUNTERING THE MASTER DECEIVER

Using the Book of Job and its first two chapters, we know the Devil makes trips to a courthouse in the second heaven where he requests the right to strike and injure God's people, in order to break them and inflict so much pain, that the person will curse God.

Obviously, the Devil must have requested permission to tempt Adam and Eve and it forced God to supply Satan with something he could use as a temptation. The object was the Tree of Knowledge of Good and Evil, which was placed in midst of the Garden next to the Tree of Life. (Genesis 2:9)

God foreknew that Adam and Eve would not be able to resist the Devil. Therefore He designed a redemption plan for the human race before the creation of the world. (Genesis 3:7; Ephesians 1:1-4; 1 Peter 1:18-20; Revelation 13:8)

Satan did not have a physical body and could not enter the Garden of Eden and engage Eve. The Bible does reveal how Satan was able to receive permission from the serpent to possess his physical body and use it to speak to Eve. If the serpent was innocent, he would not have been punished. (Genesis 3:14-15)

Lucifer is known as Satan, the Devil and that old Serpent. (Revelation 12:9)

God set up a chain of command with Adam in charge of Eve and she was made aware of this arrangement. (Genesis 2:20; 3:16)

Eve was the weaker vessel and this is why she was targeted by Satan. (1 Peter 3:7)

Satan removed the spiritual covering from Eve by approaching and engaging her in a conversation that was not lawful for her to have. Once he began talking to Eve, he was able to deceive her into eating the fruit forbidden by God.

This brings us to another revelation; the animals could speak and communicate with human beings at this time. Eve was not at all surprised when the serpent began to speak to her. (Genesis 3:1-6)

It is important to understand that Eve was the only one deceived by Satan. (2 Corinthians 11:3; 1 Timothy 2:14)

Eve was deceived by the serpent but Adam was in the greater transgression when he made the conscious choice to obey his rebellious wife instead of the Lord. (1 Samuel 15:22-23)

AS THE DAYS OF NOAH

Jesus told us that if we watched for certain signs, we would be able to tell how close we were to the second coming of Christ. Twice in the New Testament, we read that just prior to the coming of Christ, life on earth would be the same as it was in the days of Noah before the flood. (Matthew 24:37-39; Luke 17:26-27)

If Jesus warned us that life on earth would revert back to the way it was in the days of Noah, it should be very important to determine what life was like before the flood. In order for Christians to understand the signs before His second coming, we must learn how it was in the days of Noah! Suddenly it became important to find out more about the times of Noah.

The Bible tells us there will be a falling away from faith in Christ and that a world dictator will

precede the Second Coming of Christ. (2 Thessalonians 2:1-17; Revelation 13:1-18)

"But as the days of Noe were, so shall also the coming of the Son of man be." (Matthew 24:37)

For many years I have been reading this verse but not fully understanding what it meant. When I read the sixth chapter of Genesis, I understood that fallen angels had taken human wives and created some kind of hybrid race that were angel/human beings called "giants" in the Bible. The Hebrew word used for giants is "Nephilim," which means "fallen ones." This understanding is supported by Peter and Jude. (2 Peter 2:4; Jude 6)

THE BOOKS OF ENOCH

For a number of years I thought there must be some kind of written record that would provide more insight into the time of Noah. I knew that written material existed in the nation of Israel which was not included in the Bible. The Roman Catholic Church has the "Apocrypha" but I did not want to read it. However, the book of Enoch kept coming to mind and I decided to investigate it.

THE LIFE OF ENOCH

Enoch was born when Adam was 622 years old and they were alive together for 308 years. Enoch was taken by God 57 years after Adam died. He was the 7th generation from Adam. The Bible does not state a lot about Enoch except for the following verses:

"And Jared lived an hundred sixty and two years, and he begat Enoch: And Jared lived after he begat Enoch eight hundred years, and begat sons and daughters: And all the days of Jared were nine hundred sixty and two years: and he died.

And Enoch lived sixty and five years, and begat Methuselah: and Enoch walked with God after he begat Methuselah three hundred years, and begat sons and daughters: And all the days of Enoch were three hundred sixty and five years:

And Enoch walked with God: and he was not; for God took him." (Genesis 5:18-24)

"By faith Enoch was translated that he should not see death; and was not found, because God had translated him: for before his translation he had this testimony, that he pleased God." (Hebrews 11:5)

"And Enoch also, the seventh from Adam, prophesied of these, saying, Behold, the Lord cometh with ten thousands of his saints, To execute judgment upon all, and to convince all that are ungodly among them of all their ungodly deeds which they have ungodly committed, and of all their hard speeches which ungodly sinners have spoken against him." (Jude 14-15)

Both Peter and Jude quoted the writings of Enoch in their respective books. Even more astonishing is the fact that Jesus is repeatedly referred to as the "Son of man" in the four Gospels. This reference is also found in the Old Testament. I had never looked upon this title and wondered what it meant. My investigation of Enoch led me to the following text:

"At that hour, that Son of man was given a name, in the presence of the Lord of the Spirits, the Before Time, even before the creation of the sun and the moon, before the creation of the stars, he was given a name in the presence of the Lord of Spirits. He will become the light of the gentiles and he will become the hope of those who are sick in their hearts.

All those who dwell upon the earth shall fall and worship before him; they shall glorify, bless, and sing the name of the Lord of Spirits.

For this purpose he became the Chosen One; he was concealed in the presence of the Lord of the Spirits prior to the creation of the world, and for eternity." (1 Enoch 48:1-5)

When compared with what Luke wrote, it is obvious that he quoted part of this passage.

"A light to lighten the Gentiles, and the glory of thy people Israel." (Luke 2:32)

Compare this with what the apostle John wrote:

"In the beginning was the Word, and the Word was with God, and the Word was God. The same was in the beginning with God. All things were made by him; and without him was not any thing made that was made.

In him was life; and the life was the light of men. And the light shineth in darkness; and the darkness comprehended it not.

There was a man sent from God, whose name was John. The same came for a witness, to bear witness of the Light, that all men through him might believe. He was not that Light, but was sent to bear witness of that Light. That was the true Light, which lighteth every man that cometh into the world. He was in the world, and the world was made by him, and the world knew him not." (John 1:1-10)

THE BOOK OF ENOCH PRESERVED

The book of Enoch was preserved by the descendants of Abraham, not Gentile nations, and dates back to the period before the flood. It would have been preserved by Noah and his sons, just like Noah also preserved the early writings of the book of Genesis. Enoch was Noah's great-greatgrandfather.

The knowledge of the creation and the life of Adam and Eve were passed from generation to generation. The written or oral records passed from father to son down through the generations. When the flood took place, Noah and his three sons were the only surviving males. I believe the information recorded in the books of Enoch are true and reflect what life was like during this terrible time of horror that became known as the "days of Noah."

The Israelites were the only nation which received a revelation from God, worshiped the God of creation, not man-made deities. The passage I quoted from the book of Enoch clearly shows that Adam and his sons knew that the Son of man was going to be the Messiah, and that there would be salvation through Him. (Genesis 3:15)

The word for God in the first chapter of Genesis is "Elohim," which means "Gods" in Hebrew. The passage in Enoch points to the deity of the Son of man, that He is eternal, and that one day every knee shall bow before Him. This understanding by Enoch divulges his knowledge came by direct revelation from God. The Bible confirms this is true because he walked with God in a special way.

FACTS ABOUT THE BOOK OF ENOCH

The first book of Enoch is only found complete in the Ethiopic (Ge'ez) version, for which more that

forty manuscripts are known to exist as of 1983. The original language was Hebrew, while some argue that the book was written in a mixture of Hebrew and Aramaic like the book of Daniel. Fragments of the first book of Enoch were found among the Dead Sea Scrolls, which date back to around 200 B.C.

Common sense should dictate that the written history of Adam and Eve as found in the book of Genesis did not survive in its original form. The knowledge was passed on from generation to generation, and it was Moses around 2,600 years after Adam, who recorded what is today known as the book of Genesis.

My understanding is that the same process must therefore been true for the first book of Enoch. Just as the so-called Bible scholars are trying to debunk the Bible, they are doing the same thing with the writings of Enoch.

Regardless of the spin that the "scholars" put on the book of Enoch, they all agree that it was written in the first century after the death of Jesus by the Christian community. This poses a great technical problem for the scoffers since electricity and genetic engineering was unknown to mankind. Yet both the Bible and the book of Enoch speak on these subjects. My personal belief is that the information found in the Bible is a direct revelation from God, preserved by men through the power of the Holy Spirit. The additional information provided in the book of Enoch is in total harmony with the Bible, but provides further insight into the time period between Adam and Noah.

THE PROMISE TO DANIEL

The Bible is full of accounts of how God's angels changed events and rescued the people of God. Some of the most exciting events are described in the book of Daniel. (Daniel 12:3-10) According to Jesus, life on earth would revert to the way it was before the flood. The full impact of that reality is frightening to those who understand what that entails for humanity. Once again demonic entities (fallen angels) will begin to intermingle with human beings and produce a hybrid race of angel/human beings without a soul, totally evil, and void of all mercy, love and goodness. (Genesis 6:1-5)

ENOCH'S INFO ABOUT FALLEN ANGELS

Enoch tells us that Semyaz was leader of this group of the 200 fallen angels responsible for this time of unprecedented evil. When they saw the beauty of the human women, they decided to take some as wives and produce children through them.¹

My personal understanding is that this group of 200 angels prior to their rebellion against God, had been involved in the creation of human beings, and thus had the knowledge of how the human body was engineered. Using this knowledge for their own purposes, they were able to create what was needed in order to have a physical body through which they could have sexual intercourse with human women.

Semyaz did not trust the fallen angels under his command and made them sware an oath with a curse which bound them together before they started this project. I believe that this type of oath with a curse is the same kind that is practiced by Satanists, witches, Baal worshipers, Freemasons, Mormons etc. This should come as no surprise to Christians since the apostle Paul told us that demons do seduce and teach doctrine. (1 Timothy 4:1)

These fallen angels descended upon Mount Hermon in what is today Syria and this mountain became their headquarters. Now I understand where the Baal worship came from. After the

flood, demons seduced people into idol worship and Mount Hermon became a center in the Middle East, where altars were built and human sacrifices were carried out. Compare this with the religion of the Greek people, who claimed that gods lived on Mount Olympus, led by the chief god who was known for his enormous sexual appetite. In Rome he was known as "Jupiter" and the Vikings called him "Thor." The Aztec empire in central Mexico worshiped a cluster of demon gods, with high pyramid temples, where the chest of humans were cut open and their throbbing hearts were sacrificed to the sun god.

The current Olympic Games are in reality a revival of the old Zeus worship. The Olympic fire is lit on top of mount Olympus by female priests, the fire is carried to the game by torch, and then the altar is lit. There are songs and dances at the opening and closing of the games, all in honor of the old Greek gods. Is it a coincidence that the Roman Emperor Theodosius abolished the games in 393 A.D. because of their ties to demon worship? Was it by chance that the games were reinstated in 1894?

The 200 fallen angels were divided into groups of ten, each group having a leader. Enoch provides the names of each of these sub-leaders. Each of the 200 took a woman as a wife and made them pregnant. The babies born to these women grew to a height of 300 cubits (450 ft.) and consumed so much food that humanity hated them because they were forced to feed them. The giants turned their wrath on the normal people and began to kill and eat humans. They also ate birds, fish, animals, reptiles, and drank blood.

One of the fallen angels educated humanity in technology. He taught them how to mine ore, melt and extract different metals. He then taught them how to fashion swords, knives, shields and breast plates.

Those who became initiated into this demon religion were educated in the making of bracelets, decorations (shadowing of the eye); making medication (pharmakia), ornamentation, the beautifying of the eyelids, all kind of precious stones, and all coloring tinctures and alchemy.

Other fallen angels taught humans how to do incantations, the cutting of roots, how to resolve incantations, astrology and how to deceive people.

These fallen angels educated the people not only in technology which was used to make war, but also in occult practices, releasing more demon power on the earth.

This gave me an understanding of why the prophet Elijah became petrified with fear immediately after experiencing a great victory on Mount Carmel.² When Jezebel sent a message to him, she did not send it as the queen, but as the high priestess of Baal. It was the demon prince of Baal possessing her, who sent this message and overwhelmed Elijah with fear.

"And Ahab told Jezebel all that Elijah had done, and withal how he had slain all the prophets with the sword.

Then Jezebel sent a messenger unto Elijah, saying, So let the gods do to me, and more also, if I make not thy life as the life of one of them by to morrow about this time.

And when he saw that, he arose, and went for his life, and came to Beersheba, which belongeth to Judah, and left his servant there." (1 Kings 19:1-3)

Jezebel was a woman who from childhood had been initiated into satanic worship:

"And Ahab the son of Omri did evil in the sight of the LORD above all that were before him.

And it came to pass, as if it had been a light thing for him to walk in the sins of Jeroboam the son of Nebat, that he took to wife Jezebel the daughter of Ethbaal, king of the Zidonians, and went and served Baal, and worshiped him. And he reared up an altar for Baal in the house of Baal, which he had built in Samaria." (1 Kings 16:30-32)

When Jehu came to confront Jezebel, she went into her chambers, painted herself in the way of a Baal priestess, put on head gear, and went to the window, hoping to scare Jehu into submission. But Jehu was not intimidated and had her killed on the spot. Now I understand why Jezebel put on her make-up before she went to the window.

The fallen angels also introduced the technology of writing and the use of ink and paper. This was used to record false doctrine and preserve the incantations and ceremonies taught to the people.

The murder of babies was shown to women, where the child was killed in the womb and extracted. It is devastating to realize that the execution of babies in the womb dates back to the beginning of mankind. No wonder the feminist movement is so militant; these women are driven by powerful demonic princes who have been slaughtering babies for the last 6,000 years. With the current technology, their blood lust for killing helpless babies in the womb has now reached millions per year worldwide.

The fallen angels also introduced flagellation to people where sexual pleasure is derived from being beaten, tied up, dominated in some way by the other sexual partner, including rape.

The Bible is true, holy and powerful and we really should heed what God is saying and examine our behavior accordingly. "My people are destroyed for lack of knowledge: because thou hast rejected knowledge, I will also reject thee, that thou shalt be no priest to me: seeing thou hast forgotten the law of thy God, I will also forget thy children." (Hosea 4:6)

SUMMARY TO ENOCH

After reading the books of Enoch twice, I found that many things I previously taught by faith have been verified whereas some things are new revelations to me.

God created the beautiful Garden of Eden. The Devil brought in technology for the purpose of murder and war. It is important to understand that all technology is created by God through His spiritual and physical laws. The Devil and his fallen angels are merely using their knowledge in this area for evil instead of good.

I have believed for many years that UFO's are operated by demonic beings. I no longer think that the U.S. Air Force shot down a UFO over Roswell, New Mexico in 1947, but that Satan crash landed it on purpose so that the craft and its occupants could be captured. The government hid the craft, preserved the killed operators in vats of formaldehyde and set out to reverse engineer this new technology.

Many new exciting technologies were introduced to mankind as a result. The integrated circuit chip led to the discovery of the transistor. Then came the development of the printed circuit and the microprocessor, which led to the explosion of personal computers. Night vision image intensifier used with great success by the military allows our troops to see the enemy at night. Then came lasers, fiber optics, super tenacity fibers such as Kevlar, and depleted uranium tank rounds which can penetrate thick steel armor plate. Another product that has come on the market is "food irradiation." More advanced war technologies have been developed such as "Death Rays" and a Particle-Beam weapon.

Demons do not release technology for the benefit of mankind, but to advance mankind's ability to wage war and conduct mass destruction. God did not create this technology for war, but for the benefit of his creation. Thus, we can see that where the Christian faith is the strongest, there is also the greatest development of technology for peaceful use.

I want to emphasize that technology in of itself is not bad since it is part of God's creation and everything that God created is good.³ When the fallen angels introduced knowledge to mankind, it was not for the purpose of improving man's living conditions, but rather for weapons of mass destruction.

Lucifer was not satisfied with building human armies equipped with stone weapons, so the demons taught men how to dig mines, get and melt ore, extract gold, silver, copper and iron, then how to mix the metals to make swords, knives, spears, etc. Armies could be built with better technology to unleash massive destruction and subdue other nations.

When God destroyed the hybrid race of angel/human beings, He also established a moratorium on further technological developments, so from about 2324 B.C. to around 1700 A.D., a period of some 4,024 years, humanity did not learn any new technology, but was able to improve on what existed. During this time period, sails and men with oars was the only way to propel ships. Horses, oxen, camels, elephants and donkeys were the only power source for land travel and other works. It is interesting to note that in the 14th century Leonardo de Vinci was able to design airplanes and submarines but he had no power source for them.

Electricity was virtually unknown to humanity except those dabbling in the occult who spoke about an unknown power. When Enoch wrote about the coming flood, he described the water in the air such as with clouds and the frozen canopy of water which at the time enveloped the earth as masculine, and the water on the earth as feminine. Today we know that water clouds have a positive electric charge and lightning consists of electrons rushing up to neutralize the water in the air.

The Chinese called it "Ying and Yang," and this term is still used in occult practices. The first power source to be discovered was the water wheel which dates back for centuries.

Static electricity was discovered in 1663, followed by the steam engine in 1769. Mankind's knowledge of electricity developed during this period, and we learned about direct current and alternating current. The first water turbine was introduced in 1826, the modern steam turbine was invented in 1884, and the first functional combustion engine arrived in 1878. This was followed by the development of the rocket engine in the 20th century, the jet engine and nuclear power.

It is known in scientific circles that UFO's are powered by either electro-magnetic propulsion or reverse gravity. So far humanity has not been able to duplicate these power sources.

Satan has been spearheading technology to further weapons of mass destruction and devices to enslave people for the last 6,000 years. On the other hand, God's people have developed and enhanced known technology to give man a better life and reach a higher standard of living.

HIGH TECHNOLOGY & THE ANTICHRIST

If you read the Bible, you will realize that Satan cannot usher in the Antichrist without a high level of technology. In order for the Devil to bring about the Antichrist system, he must achieve a certain level of technology to control the masses. The gifts that the Devil has been giving to mankind over the years have been weapons of war. The bow and arrow, the catapult, the battering ram, ships with battering rams driven by chained slaves using oars, traps of different kinds etc.

Black powder was officially discovered in 1304 and this brought the invention of rifles, pistols, cannons, land mines, etc. With the discovery of smokeless gunpowder came more powerful guns, capable of killing more people faster.

With digital cameras, computers, lasers and satellites the Devil now has the technology to control all movements of people on this earth, all commerce and all banking. When the final move will come is now only a question of time, which the Bible calls the "THE GREAT TRIBULATION."

THE RISE OF THE ANTICHRIST

God has made it crystal clear that before Jesus Christ returns a second time, there will arise a world dictator who will rule the world for a short time and do the bidding of the Devil. (2 Thessalonians 2:1-12)

The book of Revelation provides more insight about the Antichrist and the system he will utilize. (Revelation 13:1-18)

The Devil is going to set up a system that allows him to control all business through a mark of loyalty. Any human being that wants to buy or sell will need this mark. Satan is also going to merge all religions into one and set up his leader called the "False Prophet."

To make this work, there must be sufficient level of technology present that allows the leadership to have instant communication to any point on the planet, then utilize military or police forces on site to deal with any resistance.

When the British Empire was at its peak, their controls were still very weak. An uprising in the American colonies would not be known in London for at least four weeks, or as long as it took a ship to sail from the colonies to London. Once the British government had been given the news, they would make a decision on what to do about it. Then it would take another four weeks before a written order could be given to the officer placed in charge of the colonies. It would also take several weeks to send more soldiers and supplies to the place where the unrest was taking place.

Today there is instant communication via satellites; troops and supplies have been stationed around the earth, and with aircraft, soldiers can be moved to any spot in less than 24 hours.

The Man of Sin will not come on the scene suddenly. His organization will be built over a period of time and only discerning believers in Christ will be able to see what is going on.

There must be some global organization that in time will supersede national governments and bring all nations under one rule. Is there such an organization in existence today? Yes, it is not supreme yet, but world leaders are working hard to bring that into being. The "United Nations" (UN) was founded in 1945. It was very weak at its inception but today it dominates more and more and continues to grow in power.

There is a "world court" located in The Hague, Netherlands. It is known as the "International Court of Justice" and it is the judicial organ of the United Nations to settle legal disputes between member states, providing advisory opinions to authorized UN organs and specialized agencies. Its rulings are considered binding upon the member nations. There are two world banks in existence known as the "International Monetary Fund" (IMF) and the "World Bank," both of which are institutions of the United Nations.

The last thing needed to complete this structure is for the UN to have a permanent military force, large enough to outgun any individual nation. The UN has so-called "peace operations" going on, but the talk behind the scenes is the need to create a "super military force" under the command of the UN. World government leaders are discussing how to implement this military force. Once this is in place, all the UN needs is a new leader with dictatorial powers and the reign of Antichrist is ready to be unleashed.

SUMMARY ON THE ANTICHRIST SYSTEM

It is now more important than ever for believers in Christ to study the prophetic writings found in the Bible, learn what it means, and how it will affect the people living on earth. This will certainly increase our drive to evangelize and tell people about Christ before it is too late. After all, the most important thing to any person is to hear about God, the redemption provided by Jesus Christ and receive eternal life. Life on earth is temporary and all of us will depart from earth someday. Heaven and hell are the only two places which we can exist.

EVIL SPIRITS IN THE OLD TESTAMENT

When the book of Judges was written, there was no revelation about evil spirits (devils, demons). God used an evil spirit to bring judgment upon Abimelech. (Judges 9:23)

When the Holy Spirit departed from King Saul, an evil spirit came and possessed him. (1 Samuel 16:14-15)

There came a time when God decreed that King Ahab of Israel was going to die in a battle and He utilized a lying spirit to deceive Ahab. (1 Kings 22:20-23)

EVIL SPIRITS IN THE NEW TESTAMENT

When Jesus came to the earth to start His ministry, He began addressing the problem of people being afflicted by evil spirits. The people in Galilee, Samaria and Judah were astonished that He had the power to cast out evil spirits and cure people who were vexed by them. There are a number of recorded incidents when Jesus cast out evil spirits, but the general ministry on a daily basis was to preach the Gospel, cast out demons and heal the sick. (Matthew 8:16-17)

Here are some examples:

- The Gergesene demoniac. (Matthew 8:28-33)
- The man that was dumb and could not speak. (Matthew 9:32-33)
- The blind and dumb man. (Matthew 12:22-24)
- The Canaanite woman's daughter. (Matthew 15:22-28)
- The demoniac in the synagogue. (Mark 1:21-27)
- The boy with seizures. (Mark 9:14-29)
- Jesus cast out seven evil spirits from Mary Magdalene. (Luke 8:1-2)

If a lot of people were afflicted by evil spirits during the time Jesus was here on earth, is it not logical to assume that the status quo has not changed or gotten worse over time? Experience has shown me that most Christians do not know they can be set free since the church seldom preaches on this subject.

THE OFFICIAL PROGRAM OF JESUS

Jesus provided the twelve disciples with an official work assignment that consisted of casting out evil spirits, healing all manner of sickness, cleansing the lepers, preaching the Gospel, and raising the dead. (Matthew 10:1-8; Luke 9:1-2; Luke 10:1; 17-22)

After the resurrection of his dead body, Jesus issued a final instruction to His disciples. They were to commission their followers to continue in the same tradition until Jesus returned a second time to the earth. (Matthew 28:18-20)

GET ON BOARD WITH JESUS

The apostles never recorded the procedure that Jesus used when He cast out the demons. The only thing that Jesus stated was that some evil spirits could only be cast out if the person casting out the evil spirits had fasted and prayed beforehand. (Mark 9:28-29)

Jesus made it clear to His followers before His crucifixion that there were many things He had not told them. They would receive further instructions from the Holy Spirit. This means that the Holy Spirit will continue to reveal what Jesus wants done from generation to generation. (John 16:7-15)

I have been casting out demons from people since 1970 and I found over the years that the Holy Spirit has consistently guided me into truth about this subject. I do not claim to have "the method" but we utilize "a method" that works well.

EAEC DELIVERANCE PROCEDURE

Here are the steps to achieving the abundant life promised by Jesus:

- 1) Identify and discuss the 92 biblical curses found in Christian Dynamics Course 1. Pray over and break each curse.
- Discuss and identify all curses spoken and/or written against the person seeking deliverance.
- 3) Discuss and identify all curses that you have spoken against yourself.

- 4) Discuss and identify all family curses, going back as far as possible.
- 5) Discuss and identify all ungodly soul ties:
 - a) Heterosexual
 - b) Homosexual
 - c) Pornography
 - d) Bestiality
- 6) Discuss and identify all traumas.
- 7) Forgiveness is essential. Make a list of the people you need to forgive and also a list of people who have hurt you.
- 8) Go through hidden soul damages and shameful acts.
- 9) Identify all demons by using the demon listing sheets.
- 10) Cast out the demons.
- 11) Pray for the delivered person to be filled with the Holy Spirit.
